Our mission has remained the same for fifty years. The issues are as important today as when we started.

The NPSCF was started in Saskatoon, Saskatchewan, by provincial organizations from British Columbia, Alberta, and Saskatchewan. Groups from other provinces have since joined.

It is made up of provincial affiliates, groups, clubs, and individuals.

Objectives

The National Pensioners and Senior Citizens Federation is an organization devoted entirely to the welfare and best interests of Canada's elderly.

- To promote and establish and foster, Seniors' Centres (called Clubs or Groups) and Regional and Provincial Seniors' groups throughout Canada.
- To provide education for persons in the retired and senior citizens age group and other individuals interested in aging, and the status and well being of seniors.
- 3. to reach out to seniors who are lonely, or isolated, or at risk..
- 4. To provide programs, which promote healthy active lifestyles for seniors, thus sustaining mental and physical health.

- To assist in developing the knowledge that seniors should learn during their aging process, through promotion of educational experiences.
- 6. To research the aging process, and any problems and benefits pertaining to the aged that might be of interest to the Federation, and to use the knowledge gained from that research to educate seniors and any other party or parties who are or might become interested in these concerns.
- 7. To provide opportunities for seniors to utilize their volunteer and leadership skills for the benefit of all persons.
- 8. To consult with other private and public organizations which offer similar services in order to gather any education information that will add to knowledge and be of use in seniors and the public.

CHANGES AT NATIONAL PENSIONER AND SENIOR CITIZENS FEDERATION

The 2008 NPSCF convention held in Surrey BC was a great success. 97 delegates debated 82 resolutions and enjoyed the different guest-speakers. Folksinger Tommy Hawkins got every one singing, so besides the serious business, delegates had some fun. There were some changes among the officers; Art Kube was elected President and Sandy Carricato from Port Perry, Ontario was elected Treasurer. Art Field remains as Past President, a member of the Executive. Joyce Mitchell is leaving the Executive. We all thank her for the many years of service.

The Convention gave the incoming Executive a strong mandate for some major changes. The Executive was instructed to obtain the services of a part-time General Secretary who will also act according to the constitution as the Chief Financial Officer. This person will be working out of Ottawa. The General Secretary will be the NPSCF link to the different Government Ministries and keep our affiliates apprised of all government programs and policies effecting seniors. He or she will also explore all funding possibilities for our affiliates. The Ottawa office will act as a clearing house for information and programs for affiliated organizations.

The Executive will work on changes to the constitution to bring it into the 21st Century. We will also work to streamline the method we use to deal with the resolutions, such as combining some duplicate resolutions and also make sure that they reflect the values of the organization. The question of representation will be looked at, as well as the terms of the officers, to assure some continuity. The officers will hold bi-weekly teleconferences to conduct the business of the organization. The officers will also engage in fundraising and in affiliation drives. We will also attempt to set up provincial seniors' council where presently none exist, and assist provincial councils whenever possible. It is our sincere desire to hear from you as to your activities and also your concerns. The incoming Executive is committed to be responsive to the needs of all seniors so we can be truly the voice of seniors in Canada.

We need all your help in the process. To improve communication with our affiliated organizations, clubs and individual members, we would appreciate it if you would provide us with E-mail addresses so we can send you things electronically. Not only is this faster but it is also much cheaper, and it is also much easier for you to reproduce the information we send you.

The Executive is seeking sponsorship to hold the next convention in Ontario, preferably in a hotel which has reasonable room and meal rates. We will also seek funding to equalize the travel costs of the delegates. The high cost of coming to the convention makes it very hard for some of the smaller affiliates and clubs to send delegates.

Our new Executive is committed to meaningful change, change which will serve the needs of seniors and a civil society generally, our members especially. With your help we can do it. For more information look at our web-site www.npscf.org.



Professor Irving Rootman University Victoria BC, spoke on "Health Literacy" a vital component of "Health Promotion".

Dr. Garnet Grosjian University of BC delivered a message on "Health, Seniors Housing/Aging in the community". Had a slide presentation and discussion afterwards.

"Profit versus Non-Profit Housing" was presented by Glen Huddrel former director of Co-Operative Housing Foundation of Canada. "Discrimination in Seniors Housing" by Charmaine Spencer Professor in Gerontology Research Centre.

Our dinner Speaker "Dr. Patricia Baird" spoke on "Aging and Seniors Issues" which happens, as we get older.

The theme of this conference was "Don't Plan For Seniors" – "Plan with Seniors", which I believe we should use in all our correspondence with governments.

This was a very well planned and presented conference. Congratulations to Art Kube and his committee.

Following this we were off to Surrey BC, where the NPSCF convention was held at the "Compass Point Inn".

We were welcomed to the city of Surrey by Lisa White, Manager of Sports and Culture in the absence of their Mayor, Art Kube, President of Cosco, (the host organization) and Art Field President of NPSCF.

The credential report by the Treasurer was 95. Attendance was down compared to years past, our executive discussed this with the decision being a more central location would be more compatible to all Provinces and the Territories this enabling more to attend. There were about 75 resolutions put forward by the "Resolution committee". Home, Health and Income, were all well debated. Those deemed priority will be put in a brief prepared by our President Art Kube, to be presented to the Federal Government in the New Year.

One of my main concerns, is the selling off of our "Fresh Water", to our neighbors in the South, if governments are allowed to continue this practice, we in Canada will be paying a huge price for our own resource. We have to stand firm and demand that it will not happen.

"Independent Living" is troubling many of our seniors. The majority of seniors want to remain in their own home independently as long as their health allows. They want to make choices based on their needs in all stages of life, regardless of their ability to pay. This gives them a sense of dignity and self respect which keeps them happier and healthier.

This way they are able to continue to participate in their own community as full citizens. Happiness for seniors is family, precious memories, where sons, daughters and grandchildren are welcome. The problem of late has been, the governments are choosing when health issues arise, to split a couple up sending them out of their own community because there isn't a policy in place where these seniors can get the help required to maintain their family values, and enjoy their twilight years together as a family unit.

We need to lobby Governments to come up with a Universal Home – Support Program so as to extend the time seniors can live independently and maintain their quality of life, reducing the time for residential care and decrease health care costs and the cost of building more residential centers.

We also have to impress on the Government to bring our "Old Age Security Pension" in line with the ever-increasing cost of living.

Overall, I feel it was a productive convention. At this time I want to congratulate those individuals who were successful in the election and thanks to last years executive who helped pave the road for the Future.

From My House to Yours - Secretary



National Pensioners and Senior Citizens Federation Accomplishments on Retirement Security

October 8, 2008

Since 2006, the National Pensioners and Senior Citizens Federation has supported my research and recommendations for improved investor protection of senior's retirement savings. We have together had a significant impact on raising public awareness of serious financial abuse in our country. Our government legislators and the financial industry are listening. The victims of financial abuse are finally getting restitution for their loss of lifesavings and the investment protection law reform process has begun.

At its National Conference in Truro, Nova Scotia on September 19-23, 2006, the National Pensioners & Senior Citizens Federation adopted a resolution to clean up the misrepresentations in how income trusts were being sold to seniors. On October 18, 2006, the NPSCF held a media conference in Ottawa and went beyond its clean-up request to asking for a moratorium on new income trusts due to: (a) these businesses not paying their fair share of income taxes needed to fund the CPP, OAS and GIS benefits for seniors; and (b) the significant losses seniors owning income trusts were experiencing due to the product's flawed structure and misrepresentations in its sale. Thirteen days later, on October 31, 2006, Federal Minister of Finance James Flaherty introduced a new income trust tax, that shuts down income trusts altogether by 2011. The aggregate losses on business income is now \$25 billion, which is more than the amount I had predicted when I did my first research report on the problems with business income trusts in November 2005.

Recently 1,800 Canadian families, a high proportion of which were seniors, waged a very public battle against Canaccord, Credential and Scotiabank to achieve a \$200 million plus full cash settlement for their frozen Non Bank Asset Back Commercial Paper, sold to them as a top credit rated and safe savings product. These families had their life savings tied up for 14 months, creating both financial distress and a variety of health consequences.

Donna and Bruce Boyd of Mill Bay, British Columbia sold their home and have \$428,000 tied up in ABCP. Their new home bought for retirement is funded by a BMO loan costing them \$2,700 each month. "We are struggling to keep our home and retirement at this stage is only a dream." The fought for Canaccord Customer Relief Plan is returning the Boyds' life savings.

Janet Carey's 89 year old mother lives in Kitchener, Ontario and she suffers from Alzheimers. The money from the sale of her home was placed in ABCP. Janet funded her mother's nursing home expenses, and will be much relieved when her Credential settlement is paid in October 2008.

One man spoke to us confidentially because he did not want his 73 year old mother and 95 year old grandmother to find out their life savings are frozen in ABCP. The grandmother's home was sold to pay for her nursing home expenses. Without the cash settlement from Credential, "my 95 year old grandmother is living with my Mother, following hip replacement surgery. How long my Mother will be able to look after my grandmother is uncertain. At present, without family support, or the sale of my Mother's house, there are no nursing home funds for my Grandmother."

Gulmahomed Kapadin, a 79 years old, said: "When purchasing this investment I was assured that it had AAA rating but now I find that these top ratings are not reliable. It will be a great financial loss for me at this age and disability I have."

Taras and Sharie Kuchers of Toronto, Ontario say, "we are reaching retirement and our health is dictating a need to stop working shortly. All our funds and RRSP's were in this commercial paper, so we have nothing left."

Dave and Alvina Nicholas say, "As senior citizens we too have an expectation that the government will protect their citizens from fraudulent practices in the banking system. It has created hardship as I have been forced to return to work and am now suffering from high blood pressure and other symptoms of severe stress... It is hard to believe that these highly leveraged devices were ever allowed to be sold in Canada. Clearly we would like to see criminal action taken against those involved."

Gary Webber a pastor and an ABCP victim himself informs us that "The effects on many people's lives have been devastating _ the fear that surrounds the possibility of losing the money has been even debilitating for some of them. As a pastor my concern is for the personal distress that results as people are placed in these situations that they are really powerless to effect."

And, Yulan Wong a retiree says, "I do not eat and cannot sleep. I have excruciating pain (physical and mental) constantly being anxious and still in shock. ... When the account was opened with my niece's money (some belonging to her siblings) she strongly emphasized that she only cared about the capital being preserved as stated in your Account Information form. Her knowledge about investment is limited to cash in a savings account. She lost both her parents to cancer and I have reminded Mr. Evans constantly that I have to be most careful with the funds entrusted to me?

In light of all these sad stories from seniors owning ABCP, Art Field, Past President of NPSCF was moved to write a letter to the National Bank of Canada on July 2, 2008 asking that it not use the Hardship Test from the Portus Alternative Asset Management Inc. receivership in any dispute. The "Portus Hardship Test," is the "Cat Food Test," by another name. Under this test, seniors get only enough cash back to pay for the necessities of life and where alternative sources of funds for the client are limited. Seniors cannot tolerate banks and securities dealers taking their savings in defective income products said to be safe and top credit rated and then get back only enough of their savings to put food on the table and a roof over their head. Denise Dubé Director of Public Relations for the National Bank has replied "We take note of your position with respect to the ABCP restructuring as outlined in your letter."

On October 6, 2008, the Canadian Securities Administrators have put forward a new regulatory regime for commercial paper that will go a long ways towards preventing this kind of savings product abuse in the future. The country will now move to full public disclosure on commercial paper and it will eliminate the reliance on credit rating agencies to get this product into the public marketplace. Credit rating agencies will become regulated to ensure the quality and integrity of their work applicable to income products sold to Canadians.

Sophisticated market players have co-opted the investment industry and accounting industry self-regulatory organizations and even the provincial securities commissions and the Office of the Superintendent of Financial Institutions, who are suppose to be government authorities with public interest mandates. There is both rogue fraud and systemic negligence and fraud going on in the investment industry, with seniors and other retail investors being the predominant victims. In addition to securities crimes not being investigated or prosecuted, the banking and investment industries routinely receive regulatory and legal protections, that promote industry profitability and are contrary to investors' interests.

Many details of securities regulation and securities crime policing reform need to be worked-out, I request the continuing support of the National Pensioners and Senior Citizens Federation for more work to be done on investor protection to ensure retirement security.

- A new Canadian Securities Commission that provides effective investor protection regulation and enforcement and provides a simple and inexpensive process for obtaining restitution of damages caused by securities violations.
- A new securities criminal intake and assessment system jointly administered by the RCMP IMET and the fraud squads and anti-rackets units of the provincial and municipal police forces of Canada. This new system would eliminate the current reliance of securities crime police on the investment industry self-regulatory organizations and provincial securities commissions for case referrals, information sharing and expertise.




